The U.S. Journalist Assistance Network, a coalition of U.S. press freedom organizations specializing in journalist safety and assistance, has compiled a list of immigration-related resources for journalists in the U.S.

Together, this guidance can help journalists, editors, and newsrooms navigate threats to their staff and freelancers related to their immigration status or coverage of immigration issues. The resources also highlight how to prepare for risks foreign journalists may face when entering the U.S.

RCFP: Immigration Reporting Legal Guide

This RCFP guide, published in English and <u>Spanish</u>, helps journalists navigate legal issues they may encounter while reporting on immigration enforcement and deportation.

CPJ Safety Advisory: Traveling to the US

This CPJ safety advisory offers safety advice for journalists traveling to the U.S., including on assessing risk and digital security precautions.

FPF: Preparing devices for travel through a US border

This FPF guide helps journalists prepare their digital devices for transit through a U.S. port of entry in order to preserve the confidentiality of their most sensitive information.

FPF: Module: Digital security 101 — Crossing the US-Mexico border

This FPF college journalism curriculum module teaches students how to protect themselves and their digital devices when working near and across the U.S.-Mexico border.

IWMF: Tips for Covering Immigration

There are several safety measures and best practices you can follow before starting your coverage on immigration issues – like an ICE raid or meeting undocumented immigrants, or even an anti-deportation protest – to keep you safe and mitigate risk.

Evaluating and identifying your risk includes taking a holistic approach to your physical, digital, legal and psychosocial safety as well as the safety of your sources.
